Louis Riccio, Consultant for the RAD conversion gave a status report to the Board on the BHA' application. The Board was advised that month conference calls with HUD officials to discuss the progress and deadlines for items that still need to be completed.

In spite of the government shutdown, documents are still being submitted directly to Washington. We are awaiting the completion of the financial calculations and the Town of Boonton's response of the Waiver request in order to determine if we can move forward. The application is depending on the waiver to be approved, otherwise the application will not work.

Our target date for closing the RAD conversion is tentatively scheduled for November 2019 if all goes well.
